I.  
NAME OF COMPANY

The name of the limited liability company is CANTERBURY GROUP, LLC (the "Company") and its principal place of business is 1100 Logan St., Denver, CO 80203.

PERIOD OF DURATION

The period of duration is twenty-nine (29) years.

III.  
PURPOSE

The Company is organized for any legal and lawful purpose pursuant to the Colorado Limited Liability Company Act, including but not limited to the ownership and operation or real property, and participating as a member in other limited liability companies.

Initial members shall be persons or entities having a financial interest in the Company who have executed the Operating Agreement. Transfer of an interest in the Company and membership in the Company is restricted as provided in the Act and in the Operating Agreement. Voting shall be as provided in the Operating Agreement.

OPERATING AGREEMENT

The Operating Agreement of the Company shall be executed by each member of the Company and shall set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with law or these Articles.

VIII.  
CONTINUATION UPON WITHDRAWAL OF MEMBER

The Members shall have the right to continue the Company upon the withdrawal of a Member, so long as there are at least two remaining Members, and the remaining Members agree to continue the Company by unanimous written consent within 90 days after the withdrawal of a Member, as set forth in the Operating Agreement of the Company.

LIABILITIES OF MEMBERS AND MANAGERS

Members and managers of this Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of this Company.

INDEMNIFICATION OF MANAGERS, EMPLOYEES OR AGENTS

The Company shall indemnify the managers, employees, or agents of the Company to the fullest extent allowed by the law of Colorado as provided in §7-80-410 Colorado Revised Statutes, as the same may be amended.

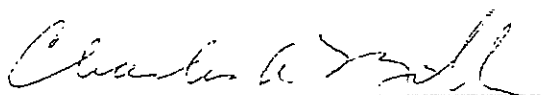
